Terms & Conditions:-

Government servant/in service candidates will be allowed 5 years relaxation if applied through proper channel, SC/ST & OBC, Ex-servicemen and PWDs will be allowed relaxation as per GOI rules applicable from time to time only in the reserved posts, no relaxation will be allowed in unreserved posts. Employees of ICMR/ Ministry of Health will only be considered as departmental candidates for age relaxation.

- Age will be reckoned last date of Walk in Interview. (2). OBC Candidates are required to submit the case certificate issued by competent authority in the prescribed format (Appendix-3) as per GOI instructions latest by 3 years old as on date of publication of this notification. "Form of certificate to be produced by other backward classes applying for appointment to posts under the Government of India". Candidates working/have worked on the long term projects in ICMR Institutes/Centers shall be given one time age relaxation, provided they meet the essential qualification and experience prescribed for the post, with a view to provide them opportunity to complete with the other candidates, subject to approval of ICMR. (3). These posts are purely temporary and co-terminable with the scheme. Initially employees will be engaged on consolidated pay basis initially for a period of one year that may be extended for further two year more on year to year basis, if work found satisfactory and feasibility of office. The term of engagement can be extended on yearly basis. Preference will be given to the candidates having higher qualification and work experience, flexibility in RR & age may also be relaxed in deserving cases, if Selection Committee recommends. Candidate will not have any right to claim for regular appointment in the Council. (4). The appointment will be made on the basis of results of Walk in Interview.

Note:- UR-Unreserved, SC/ST- Scheduled Castes/Tribes, OBC- Other Backward Classes, PWDs- Persons with Disabilities. Reserved post may be filled either with SC/ST in case of non-availability of suitable candidate in relevant category of advertised post.
