General Conditions: The post is purely temporary and co-terminable with the project. Preference will be given to the local candidates and having higher qualification and work experience. The selected candidate will have no claim for regular appointment under ICMR/ ICMR-NIRTH. No TA/DA will be paid for attending interview. Age may also be relaxed in deserving cases. Candidates who wish to appear for the **walk-in-interview** can download the application format given in the website of NIRTH (www.nirth.res.in). Duly filled in application along-with copies of certificate should be submitted at **10:00 AM**. Late entry will not be considered. Candidates are required to mention their complete address with Pin Code, Mobile number and E-mail ID.

Terms and conditions:- (1) Age is relaxable up to five years for Government Servants and SC/ST/OBC/PWD's candidates in accordance to instructions of DOPT issued from time to time only in the reserved posts, no relaxation will be allowed in unreserved posts. Employees of ICMR/ Ministry of Health will be considered as departmental candidates for age relaxation. Departmental candidates or candidates working/have worked on projects of ICMR Institutes/Centers shall be given one time age relaxation, provided they meet the essential qualification and experience prescribed for the post, with a view to provide them opportunity to compete with other candidates. If the candidates of reserved category are not available, appointment will be made from the candidates of other categories as per the recommendations of the selection committee.

(2) Age will be reckoned from the date of Walk-in-interview.

(3) Preference will be given to the candidates having higher qualification and having work experience in TB related field survey, Laboratory and RNTCP Program.

(4) OBC candidates are required to submit the caste certificate issued by competent authority in the prescribed format (appendix-3) as per GOI instructions latest by 3 years old as on date of publication of this notification.

(5) These posts are purely temporary and co-terminable with the project. Employees will be engaged on consolidated pay basis initially for a period of one year. The terms of engagement can be extended on yearly basis. .

(6) The appointment will be made on the basis of results of competitive examination/test/ and interview.

(7) Candidate will not have any right to claim for regular appointment in the ICMR-NIRTH, Jabalpur or in the ICMR, New Delhi.

(8) Candidates willing to apply for the post may download application form from the ICMR-NIRTH website (www.nirth.res.in). They are required to bring application duly completed in all respect together with recent passport size photograph and self attested copies of mark sheets/certificates at the time of walk in interview.
