Terms and conditions:- (1) Age is relaxable up to five years for Government Servants and SC/ST/OBC/PWD's candidates in accordance to instructions of DOPT issued from time to time only in the reserved posts, no relaxation will be allowed in unreserved posts. Employees of ICMR/ Ministry of Health will be considered as departmental candidates for age relaxation. Departmental candidates or candidates working/have worked on projects of ICMR Institutes/Centers shall be given one time age relaxation, provided they meet the essential qualification and experience prescribed for the post, with a view to provide them opportunity to compete with other candidates.
