The institute welcomes applications for Ph.D. programme from candidates who are bonafide Indian citizens and having consistently good academic record.

Candidates should have strong motivation to pursue research in modern biology/social sciences leading to a Ph.D. degree.

Students with post graduate degree and having valid fellowship from CSIR/DBT/ICMR/UGC/DST-Inspire/BINC are eligible to apply.

The institute is recognized by Rajiv Gandhi Proudygiki Vishvavidyalaya, Bhopal, Symbiosis International University, Pune and Rani Durgavati University, Jabalpur for award of Ph.D. The institute has state of art laboratories with high end equipments, trainee hostel and other facilities.

The institute profile and the other facilities available at the institute are displayed on our website www.nirth.res.in The senior scientist are recognized as guides in the subjects such as biotechnology, microbiology, social studies ,economics etc. and have ongoing funded projects on various aspects such as Parasitology (malaria), Haemoglobinopathies, Tuberculosis Virology, Entomology Flurosis etc.

The list of available projects for the current session will be provided to the candidates at the time of interview.

ELIGIBILITY FOR Ph. D. PROGRAMME:

- The candidate shall fulfil all UGC/ University criteria for Ph.D. enrolment.
- The candidate should have Postgraduate degree in any branch of Life Sciences/ Biological Sciences/ Biotechnology/ Microbiology/ Bioinformatics with at least 50% or equivalent Grade Point Average (GPA).
- The candidate should hold a valid Junior Research Fellowship from CSIR/UGC/ICMR/DBT-INSPIRE/BINC on the date of joining.
- Candidates who have qualified GATE or only Lectureship in CSIR-UGC (NET) are not eligible to apply.
- The staff working in long term projects, the permanent staff and self supported candidates who will qualify universities entrance exam and fulfil UGC norms will be considered on case to case basis.
- The institute does not take any responsibility to provide any financial assistance.
- Other terms and conditions of the fellowship will be as directed by the agency awarding the fellowship.

- The upper age limit for JRF shall be 28 years which will be relaxed up to 5 years in case of candidates belonging to SC/ST/Women/PH and 3 years in case of OBC candidates. Those who have already availed fellowship in other organizations and seeking transfer should clearly indicate so on their application.
- There will be no relaxation against unreserved positions as per Govt. of India Order No.36011/1/98.Estt. (Res.) dt.01/7/1998.

APPLICATIONS:

- Attach photo copies of the fellowship award letter and mark-sheet of last qualifying examination along with the application form.
- Do not attach any other certificates (Original or Photocopy) along with the application form.
- SC/ST/OBC candidates should attach self attested true copy of the Caste Certificate/Latest non-creamy layer certificate along with the application. However, all the original documents must be produced at the time of interview, failing which candidates will not be interviewed.

PERSONAL INTERVIEW:

- Personal interview of the short listed candidates will be held at NIRTH, Jabalpur the dates will be displayed on our website.
- No TA / DA will be provided for attending the personal interview and the selected candidates may need to stay for two or three days more for finalization of guide.
- Mere fulfilling of the minimum requirements stipulated in the advertisement would not automatically entitle a candidate for selection. The decision of the Institute shall be final and binding in this regard.
- Canvassing in any form and/or bringing in any influence, political or otherwise will be treated as a disqualification.
- Candidates should bring all the original and self attested copies of following documents while attending the interview.
