Late/delayed/incomplete applications will be summarily rejected without any intimation, only eligible candidates will be allowed for interview. Canvassing in any form will be a disqualification. Candidates are required to mention their complete address with Pin Code, Mobile number and E-mail ID.

1. Qualification & experience should be in relevant discipline/field from an Institution of repute. Experience should have been gained after acquiring the minimum essential qualification.
2. Mere fulfilling the essential qualification does not guarantee selection.
3. Persons already in regular time scale service under any Government Department / Organization are not eligible.
4. Candidates who will be interviewed, if they are selected will have to produce original documents of their qualification age and experience before joining. If they are not found entitled, their selection will be cancelled immediately.

Departmental candidates or candidates working/have worked on project of ICMR Institutes/ Centre's shall be given one-time age relaxation to maximum of five years or a completed months/year based on earlier project services, whichever is less, provided they meet the essential qualification and experience prescribed for the post, with a view to provide them opportunity to compete with other candidates.
