Sub: Publication Screening Committee of ICMR-NIRTH, Jabalpur - reg.

The Director, ICMR-National Institute for Research in Tribal Health (ICMR-NIRTH), Jabalpur constituted a "Publication Screening Committee" for evaluation and review of manuscript submitted for publication under affiliation of ICMR-NIRTH. This circular shall be effective on any manuscript submitted after circulation of this circular. The constituted committee comprises following members:-

Modalities:

1. All scientists/technical staff sending a manuscript for publication under affiliation of ICMR-NIRTH must send fully-formatted manuscript (including tables & figures) will submit to the member secretary through email.
2. All manuscript will be accompanied with a filled-in form (format supplied to all scientist, and will also be available at the website for download).
3. The Member Secretary will immediately send the manuscript to all the members by email, requesting them to go through the manuscript and send their comments at the earliest back to the Member Secretary.
4. The member Secretary then will compile the credible comments of all members and put before the Chairperson (i) print copy of the comments (ii) printed first page of the manuscript and (iii) printed filled-in format. The member Secretary should not, in any case keep the manuscript beyond 36 hours with him.



5. Scientists of ICMR-NIRTH responsible for the manuscript must indicate at this stage whether they seek any financial assistance if they intend to publish in an open access journal. Approval for publication fees after this stage might be difficult.
6. The comments with approval/revision after approved by the Chairperson must be sent to the author-scientist not more than 48 hours after submission (including holidays, weekends etc.) to the member Secretary.
7. The Member Secretary, upon approval of the manuscript for sending for publication will allot a unique number that the authors must include in the "acknowledgement" section of the manuscript.
8. If the Member Secretary is going for a long holiday, she/he can request another member under prior information and approval of the Chairperson.
9. The Member Secretary can send the manuscript to any other scientist (in addition to all members), as she/he will deem fit based on the subject expertise of the manuscript.
10. In case all members cannot return their comments, comments from a minimum of three scientists/members can also be processed for obtaining decision from the Chairperson.
11. Evaluating members/scientists must not comment on unnecessary scientific things; the author knows much better on the science of the manuscript. The evaluating members must see the English language, ethics properly followed or not, conflict of interest on authorship as known to her/him, etc.
12. In case one (or more) members are submitting manuscript, then they cannot evaluate their own manuscript; the member Secretary must send the manuscript to others scientists based on their expertise for evaluation.
13. In case there are some major changes (title, conclusions, additional experiments, data etc.) after the approval of the manuscript (but before the publication), the concerned scientist must inform such changes in detail to the Member Secretary in writing, citing the Manuscript number assigned to him.
14. Upon publication of the manuscript, the concern scientist must send a published copy of the paper to the Member Security for record, and also to the library.
